WHC re response to A.B.C residents spoke re that no LBC was granted for the whole building, the PC official complaint had not been fully answered, concerns raised that once any damage had been done to the grade2* wall and impact of mistakes then nothing could be done to rectify it. Three questions asked in the complaint had not been answered.
