1.	Apologies for absence. None

4.	Public Participation Session This provides an opportunity for members of the public to raise questions about and comment on items on the agenda. Excellent results were received back from the survey to residents. 93% want to save The Oak 3% were opposed. The group were trying to get a meeting set up with Mr Brar. - 9.1 PA/2024/0482 Land at Brockton Farm Paddocks, Vicarage Lane, Charing Heath: Retrospective application for the continued use of land for a 4 no plot Gypsy/ Traveller Site with 5 no mobile homes, 4 no touring caravans, 4 no existing day rooms, 3 no existing access, 3no existing sheds. 1 no new access with associated fencing and landscaping. (unanimous) (recommend refusal)
- **20/00508/AS Land south of the Swan Hotel, Maidstone Road, Charing:** Reserved matters application pursuant to outline planning permission 18/00029/AS to consider the appearance, landscaping, layout and scale for up to 131 dwellings (including up to 40% affordable housing) introduction of structural planting and landscaping, informal public open space and children's play area (LEAP), vehicular access from the A20/Maidstone Road and associated ancillary works (unanimous) (recommend refusal)
- **9.3** PA/2024/0520 Building adjacent to Kenylon Farm, Egg Hill Road Charing: Change of use and conversion of a redundant agricultural building and land within its curtilage to a dwelling house, along with landscape, parking and ecological enhancements following demolition of part of the building.
